# **Definition of Spouse**

According to the definition of the plan, the spouse is defined as the person who:

- i) is married or in a civil union with the member; or
- ii) has been living in a conjugal relationship with the member who is neither married nor in a civil union, whether the person is of the opposite or the same sex, for a period of not less than three years, or for a period of not less than one year if:
  - at least one child is born or to be born of their union; or
  - they have adopted jointly at least one child while living together in a conjugal relationship; or
  - one of them has adopted at least one child who is the child of the other during that period; or
  - the member is subject to the rules of federal pension legislation (employees of Transport Bourret Inc.).

In accordance with pension benefits legislation and the terms of the plan, your spouse may be entitled to certain benefits following your death, regardless of any other beneficiary(ies) you have named. Benefits not payable to your Spouse will be paid to your named beneficiary(ies) or to your estate, as applicable
